

Official Rules for Public and Shooter Only Drawing

- **Purchase:** Drawing ticket purchase is necessary to enter or win. The purchase price is \$10 each, 6 for \$50, and 13 for \$100.
- **Eligibility:** You are eligible if you are a legal I resident of the *United States and are 18 years of age or older on 5/2/19* and possess a valid driver's license. Employees of Health Services of North Texas are ineligible to win.
- **Background check:** The winners must pick up Firearms at from the designated vendor within 2 weeks (by May 17, 2019). Winners must pass all required background check to be eligible to receive the firearm.
- **Timing:** The drawing will be held on May 3, 2019 mid-day, Central Standard Time. If not present, the winner will be notified by email or phone. The winner will have to come forward within two weeks by May 17 before 5pm. Attendance is not necessary to win for Colt 45.
- **How to Enter:** No entry limit per person. On the official entry form (ticket), all information fields must be fully and accurately completed and legible or the entry will be void.
- **Refunds:** None.
- **Proceeds:** All net proceeds to benefit Health Services of North Texas, a 501C3 Charitable Organization.

1. All Federal Bureau of Alcohol Tobacco, Firearms, and Explosives (BATFE) rules apply and by claiming a firearm prize you agree to provide all information necessary for the transfer of the firearm won.
2. Current ATFE forms will be used in the transfer process from the designated FFL to the winner.
3. Winner assumes all liability for their actions involving the prize once they take ownership of the prize. It is the sole responsibility of the winner to learn how to safely and responsibly handle, operate, and maintain a firearm. The use of firearms is inherently dangerous. The winner agrees to indemnify and hold harmless Health Services of North Texas (HSNT) and its Board of Directors and members/staff from any and all damages that may result from improper or irresponsible use of the prize and from any accidents that may result from its use.
4. Winner is responsible for any applicable Federal, State, and Local Taxes.
5. At no time will HSNT take possession of any of the firearms involved in this drawing: winners will receive firearms directly from a designated FFL dealer. All applicable laws apply.
6. HSNT limits any and all liability to the purchase price of tickets purchased.
7. HSNT, its Board of Directors and members and staff make no warranty of the firearms. Winners are to deal directly with the manufacturer or dealer in the event of problems.
8. Tickets are non-refundable, including those where the winner's background check fails to pass.
9. Tickets are non-transferable. The person designated on the ticket must claim the prize.
10. If a winner is unable to pass the background check, the ticket holder forfeits his/her right to win the prize. Cash will not be substituted for the firearm.
11. Winners will be notified by telephone, mail, or email depending upon the information provided on the entry ticket. It is the responsibility of the ticket purchaser to provide their contact information in a clearly legible and readable manner. If the contact information does not support contacting the winner the ticket will be considered invalid.
12. The drawing will be made from all tickets purchased up to the date of the drawing.
13. All information collected by HSNT shall be used lawfully and solely by HSNT and will not be sold or otherwise shared with other entities unless legally required to do so except for providing the designated FFL dealer the selected winners necessary information for claiming the prize.

The odds of winning will depend on the number of tickets sold.

- *2,000 tickets printed and sold for the Colt 45*
- *500 tickets will be printed a sold for the Glock Model 19*
